This form is for a Director/Chief Executive Officer ("CEO") to give notice of his interests in the securities of the Listed Issuer under section 133, 137N or 137Y of the Securities and Futures Act (Cap. 289) (the "SFA"). While Form C will be attached to the announcement template, it will not be disseminated to the public and is made available only to the Monetary Authority of Singapore (the "Authority").

Mr Fu's interest in the HPL Shares held by Coldharbour and Jermaine arises under the Mayfair Trust set up under the Trust Deed dated 14 April 1989. All the shares of (i) Coldharbour are held by the trustees of Mayfair Trust; and (ii) Jermaine are held by Coldharbour. Accordingly, Mr Fu is deemed to have an interest in the HPL Shares held by Coldharbour and Jermaine by virtue of section 4 of the Securities and Futures Act, Chapter 289 of Singapore.
